## Application for Incentive Award for the year 2021-22

I. Applications are invited from Scientists/Teachers operating outside funded ad-hoc projects conventionalize, written and got sanctioned due to their efforts under competitive mode for **Incentive Award for the year 2021-22** under following terms and conditions.

1. It does not apply to AICRP and such other outside funded projects, which come to the University as a policy of the funding agency, or due to persuasion of the University. This scheme is applicable only to the ad-hoc projects written by a scientist and got sanctioned due to initiative and/or efforts of the scientist as a Principal Investigator / Lead Investigator.
2. A cash award, as detailed below with a certificate from UAS, Raichur will be given to the Scientist who is the Principal Investigator / Lead Investigator at the University level for the ad-hoc research projects sanctioned and in operation during the financial year irrespective of the year in which the ad-hoc project/s has/have commenced.

3. Projects transferred due to transfer / retirement of the scientist/any other reason shall not be considered for the award.
4. The project/s once considered for the award will not be counted again during the subsequent years.
5. The Co-Investigator or Co-Principal Investigator of outside funded projects who **act as the Lead Investigator at the University level** be considered for extending the benefit of Incentive Award (**Notification No.R/B/82/2001 Dtd.04-04-2001**).
6. The projects operated during the period **01-04-2021 to 31-03-2022** will only be considered for the award of 2021-22.
7. The grants released before **31.10.2022** will be considered for the projects sanctioned by GOK – Line Departments and Private Funding Agencies

## II. RKVY Projects

1. The projects with budget outlay of Rs.1.00 lakh and above shall be awarded a certificate of appreciation with cash incentive @ 0.10 % of the total budget spent at the end of the project. The maximum limit of cash incentives is Rs. 10,000/-.
2. The awards shall be considered only after the submission of completion report of the project within stipulated period and complete handing over of dead stock materials to concerned department / scheme / stations.
3. The projects completed during 2021-22 only will be considered.

This incentive award shall be awarded during the foundation day 2022 of UAS, Raichur

This shall be made applicable to the teachers / scientists of UAS, Raichur who apply for the **Incentive Award for 2021-22**.

Eligible Scientists / Teachers are informed to apply in following format along with relevant supporting documents\* on or before **31.10.2022**. Applications without supporting documents will not be considered.
