The applications are invited from the eligible teachers as on **01-01-2023 to 14-03-2023** in the prescribed format through proper channel for promotion of Teachers and equivalent cadres under Career Advancement Scheme – 2006 as per 3.2.3 of Regulation governing Recruitment and Promotion of Teachers in the following academic levels:

1. Upgradation of Assistant Professor and equivalent cadres from Academic Level-10 (AGP Rs. 6000) to Academic Level-11 (AGP Rs. 7000).
2. Upgradation of Assistant Professor and equivalent cadres from Academic Level-11 (AGP Rs. 7000) to Academic Level-12 (AGP Rs. 8000).
3. Promotion to the post of Associate Professor and equivalent cadres in Academic Level-13A (Rs. 9000 AGP).
4. Promotion to the post of Professor and equivalent cadres in Academic Level-14 (Rs. 10000 AGP).

The last date to submit the Bio-data along with the application with relevant documents to the concerned Controlling Officers is **09.08.2023**.

The Controlling Officer shall verify the correctness of the eligibility of the teacher and equivalent as per the eligibility criteria mentioned in the Notification dated 19-3-2013 and forward the same through proper channel to the undersigned **by 21.08.2023**.

Concerned teacher who wish to apply for academic level 10 to 11, 11 to 12 provide one copy and from academic level 12 to 13A & 13A to 14 must provide three copies of his/her Bio-data (enclosing all the attested documents in support of their claims) along with filled application.

### **PREAMBLE :**

The processing of application forms together with Bio-data of the teachers for grant of upgradation under CAS-2006 requires lot of scrutiny etc., through experts. As such the work has to be assigned to the experts duly making payment of remuneration to them. Thus spending considerable amount from the University exchequer. Therefore, it is decided to collect processing fee from the teachers applying for the grant of promotions under CAS-2006. This issue has been approved by the Academic Council followed by the approval of the Hon'ble Board of Management. Hence the Order.

### **ORDER**

In the light of the facts aforementioned, it is decided to collect processing fee as follows from the teachers applying for grant of promotion under CAS-2006 (in the form of DD drawn in favour of Comptroller, UAS, Raichur).

Upgradation from AGP 6,000 to AGP 7,000	-	Rs. 1,000/- each
AGP 7,000 to AGP 8,000	-	Rs. 1,500/- each
AGP 8,000 to AGP 9,000	-	Rs. 2,000/- each
AGP 9,000 to AGP 10,000	-	Rs. 2,500/- each
HAG Scale	-	Rs. 3,000/- each

This order shall come into force with effect from the date of UAS Notification No. R/UASR/CAS-2006/817(A)/2012-13 dated 19-3-2013 and published in the Karnataka Gazette as on 11-7-2013.
