- i. A Bachelor's degree in any discipline of Agricultural Sciences from a recognized University.
- ii. A Master's degree in any discipline of Agricultural sciences from a recognised university with OGPA of 2.75 out of 4.00 in trimester system and / or OGPA of 8.00 out of 10.00 in semester system.
- iii. A Doctoral degree in any Agricultural Discipline.
- iv. One should have a minimum of **Eight years** of service in the cadre of Professor to become eligible to apply for the above posts in the University.
- v. A minimum of five publications in the referred journals with NAAS rating of not less than five during their service.

:INSTRUCTIONS:

1. **The applicant should have a minimum period of one year of service on the last date of submission of his / her application.**
