3. Approval of the Hon'ble Vice-Chancellor, UAS, Raichur.

The Walk-in Counseling (Mop-up Round) for admission to the vacant PG seats under PGCET(KFU) and ICAR quotas during 2023-24 for various Master's and Doctoral Degree Programmes of all the Farm Universities of Karnataka [except UHS, Bagalkot and KVAFSU, Bidar] is scheduled on 17.01.2024 at the Auditorium, UAS, Raichur from 09.00 AM onwards.

## Instructions to candidates for "Walk-in Counselling (Mop-up Round)"

- 1. To be eligible for state PGCET(KFU) vacant seats, candidates should have written the ICAR-NTA Examination, Submitted online application in CMAFFU website (https://pg-admission.kar.nic.in/) and obtained rank in PGCET (KFU) 2023-24.
- 2. To be eligible for ICAR quota vacant seats, the candidates should have written ICAR-NTA Examination, obtained ICAR-NTA Rank and possess ICAR-NTA Exam Admit Card.
- The allotment of seats under ICAR quota shall be made to Karnataka Domicile candidates first, and after this process if any seats are left vacant, they shall be allotted to candidates of other States.
- Candidates who are already admitted under PGCET(KFU)/ICAR/NRI/Any Other quota during the Academic Year 2023-24 in any of the Farm Universities in Karnataka are not eligible.
- 5. For PGCET (KFU) 2023-24 seats, the candidates who have taken "Quit" option in option entry are not allowed.
- Registration by the Master's degree candidates will be on 17.01.2024 between 09:00 to 10:30 AM in the Auditorium, UAS, Raichur.
- 7. Registration by the Doctoral degree candidates will be on 17.01.2024 between 01:00 to 02:30 PM in the Auditorium, UAS, Raichur.
- 8. Candidates should bring all the original documents and passport size photos (two) along with one set of photocopies.

- For ICAR Quota, candidates have to produce ICAR-NTA Rank/Score Card and ICAR-NTA Exam Admit Card, and for PGCET(KFU) Quota, candidates have to submit PGCET(KFU) 2023-24 Rank/Score card and hard copy of the online application form.
- 10. Payment of fees: The allotted candidates need to pay the fees as mentioned below:
  - a) Master's degree programmes:
    - a) GM/OBC Candidates: Rs.49,895.
    - b) SC/ST category students whose family annual income is more than 10 lakhs: Rs.49,895.
    - c) SC/ST students whose family annual income is between 2.5-10 lakhs: Rs.28,438.
    - d) SC/ST students whose family annual income is between 0-2.5 lakhs: Rs.6,892.
  - b) Doctoral degree programmes:
    - a) GM/OBC Candidates: Rs.62,018.
    - b) SC/ST category students whose family annual income is more than 10 lakhs: Rs.62,018.
    - c) SC/ST students whose family annual income is between 2.5-10 lakhs: Rs.36,847.
    - d) SC/ST students whose family annual income is between 0-2.5 lakhs: Rs.11,677.
  - C) The candidates of all categories who get admission to the Department of Molecular Biology and Biotechnology at UAS, Bangalore have to pay extra laboratory fees:

a) Master's degree programme

: Rs.7,986

b) Doctoral degree programmes

: Rs.9.716

- 11. The caution money will be refunded after the completion of the degree.
- 12. The allotted candidates have to pay the prescribed fees in **CASH ONLY** during "Walk-in Counselling (Mop-up Round)" process, failing which his/her candidature for admission shall not be considered.
