The successful tenderer shall execute an agreement on a stamp paper of Rs.200/- within 10 days from the date of issue of **Letter of Acceptance** agreeing to the conditions of supplying, commissioning, and testing of Lab equipments/ accessories within the stipulated period. If the tenderer does not comply within the stipulated period, the tender will be cancelled and EMD will be forfeited.
