Tenders from Joint ventures are not acceptable. 1.

Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued 2. by Government of Karnataka.

Tenders shall remain valid for a period not less than 90 days from the date of submission of tender. 3. The bidder shall ensure credit of tender processing fee and EMD into the respective receiving bank before the last date of bid submission.

EMD payments through E-procurement mode shall be made as one single transaction and payments 4. made in parts are liable for rejection.

Conditional tenders will not be accepted. The University reserves the right to reject any or all 5.

tenders without assigning any reasons.

As per Karnataka state Government order LD/300/LET/2006 Bangalore dated 01.01.2007 and 6. Government letter no PW/134/BMS/2007 dated 27.07.2007, a sum amounting to 1% of the bill amount will be deducted towards constructions labour welfare fund.

- Royalty on construction materials and other taxes will be deducted as per prevailing Government orders.
- To qualify for award of this contract, each tenderer should process available tender capacity (bid capacity) greater than total tender value of work and shall furnish qualification information as per section 3 of Standard Tender Document (KW-III and KW-III).
- All the Formats prescribed in the bid documents shall be filled in complete manner. Incomplete Tenders will not be accepted.
- 10. The Tenderer should maintain the Building during defective liability period of Iyear.
- 11. The materials like Steel, Cement etc., required for the work shall be procured by the tenderer themselves and should be got attested by the Quality Control Authority before using at site. Periodical test reports of the building materials shall be produced in this effect.
- Work done certificate should be issued by competent authority not below the rank of Executive Engineer.
- 13. The item rates quoted shall include cost of royalty charges on construction materials & other taxes as per the rates provided in prevailing cost & conveyance of all materials, Curing, Watering, unloading with all leads & lifts labour, hire charges of machinery equipments etc., complete including all incidental charges. All the items shall be executed, as directed by the Engineer in charge of the work.
- 14. The successful tenderer has to deposit 3% of contract price as security deposit before execution of agreement in any form mentioned in KW manual from nationalized / scheduled bank drawn in favour of Comptroller, U.A.S. Raichur.
- 15. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of E-procurement portal due to internet connectivity issues and technical glitches.
- 16. If the quoted amount of the successful tenderer is less than estimated cost, the tenderer has to deposit 50% of the difference amount in the form of DD or FDR drawn in favour of COMPTROLLER, UAS, RAICHUR, which will be returned after satisfactory completion of the work. (The difference amount DD/FDR shall be submitted during signing of agreement of contract along with performance security)
- Tenders from the contractors who have on hand works in this University and have not completed the same within the allotted time period will not be accepted
- The Qualification Information as per Section-3 standard tender document shall be filled properly & shall be upto date.
- Tenders submitted without Qualification Information (in the prescribed format as per Section:3) will
 not be considered for Evaluation.
- GST at 12% Shall be paid to the tendered amount separately as per Govt. Letter no. PWD 65 RDF 2017, Dated 11-10-2018.
