- Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued 1. 2.
- Tenders shall remain valid for a period not less than 120 days from the date of submission of tender. The bidder shall ensure credit of tender processing fee and EMD into the respective 3. receiving bank before the last date of bid submission.
- EMD payments through E-procurement mode shall be made as one single transaction and payments made in parts are liable for rejection.
- Conditional tenders will not be accepted. The University reserves the right to reject any or all tenders without assigning any reasons.
- As per Karnataka state Government order LD/300/LET/2006 Bangalore dated 01.01.2007 and Government letter no PW/134/BMS/2007 dated 27.07.2007, a sum amounting to 1% of the bill amount will be deducted towards constructions labour welfare fund.
- Royalty on construction materials and other taxes if any will be deducted as per prevailing 7.
- To qualify for award of this contract, each tenderer should process available tender capacity (bid capacity) greater than total tender value of work and shall furnish qualification information as per section 3 of Standard Tender Document (KW-I, KW-II, KW-III and KW-IV).
