The posts mentioned below among other posts were notified vide ref.1 and no suitable Kalyana-Karnataka local candidates were available for recruitment. The said posts have been taken as backlog and re-advertised vide ref.2 as per section 8(5) of Karnataka Public Employment (Reservation in Appointment for Kalyana-Karnataka region), order 2013 but again no suitable Kalyana-Karnataka local candidates were available for recruitment. Accordingly, the following posts were notified in terms of section 8(5) of the order under ref.4. For which, A Notification was issued vide ref. (3) for filling up of the said posts. Meanwhile, New Score Card has been adopted in the UAS, Raichur for filling up of the Entry Level Assistant Professor cadre posts vide ref. (6). In this regard, earlier Notification under ref. (3) has been now re-notified as per ref. (7).

Hence, the applications are invited from the **Kalyana Karnataka Local candidates and others** as permission given by the Government of Karnataka vide ref. (5) in the prescribed proforma for filling up the following Teaching cadre posts in the University of Agricultural Sciences, Raichur from the qualified and eligible candidates. The candidates should submit their applications before the last date fixed. **Those who have already applied in response to the Notification cited at ref. 

## QUALIFICATIONS :

### ELIGIBILITY CRITERIA FOR RECRUITMENT OF ASSISTANT PROFESSOR :

- A Master's degree with at least 55% (For traditional System) or 60% (For Trimester System) or 70% (For Semester System) marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University.
- Besides fulfilling the above mentioned qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC/ICAR/CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET.

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Regulations of the Institution awarding the degree and such Ph.D. candidates shall be

exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions: -

- a) The Ph.D. Degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) The Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The Fulfillment of these conditions is to be certified by the Registrar of the University concerned.

**Note:**

1. NET shall also not be required for such Masters Programme in disciplines for which NET is not conducted by the UGC, ICAR, CSIR or similar test accredited by the UGC, like SLET/SET.

**Note:** Detailed qualifications for concerned subjects are prescribed separately for each discipline.

**AGE LIMIT:**

- The upper age limit to apply for the entry level post of Assistant Professor or equivalent post in the Farm Universities of Karnataka is 45, 43 and 42 for SC / ST, OBC and General Category candidates respectively.

## : INSTRUCTIONS :

1. The entire notification alongwith the application pro-forma, score card and detailed qualifications prescribed for each of the posts notified are accessible from the Official website (<http://www.uasraichur.edu.in>), of the University of Agricultural Sciences, Raichur.
2. a. The candidates applying for the above said posts have to enclose application processing fee in the form of Indian Postal Order / Demand Draft for Rs.1000/- (2A/2B/3A/3B Rs. 500/- only) payable to the "Comptroller, UAS, Raichur" drawn within the period from **04.02.2023 to 06.03.2023** while submitting the filled in application pro-forma. **(Attested Caste Certificate to be enclosed)**  
**Note: Applications without processing fees will be rejected. Processing fees will not be returned under any circumstances.**  
b. SC/ST/Cat-I/Ex-servicemen or children of defence personnel killed or disabled in action and Physically Disabled persons are exempted from payment of processing fees provided they furnish appropriate certificate along with the filled-in applications in support of their claim vide circular No. ಸಿಆಸುಇ 431 ಸೆನೆನಿ 2016 dtd: 28-12-2016.
3. Candidates must possess the required qualification/s before the last date prescribed for the receipt of application. Prescribed certificates should be obtained from the competent authority on or before the last date of submission of application.
4. The Applications received after the last date and incomplete application will be rejected and filled-in applications which do not accompany the prescribed fee in the prescribed manner are liable to be rejected. The processing fee shall not be reimbursed in any case.
5. The relevant documents (such as SSLC or Date of Birth Certificate) in support of date of birth must be enclosed.
6. Latest Valid Caste Certificate issued by the Tahasildar must be enclosed who are claiming the reservation.
7. Separate applications with separate prescribed fees are required for each of the posts applied for. Applications for two different posts should not be tagged together.
8. Number of vacancies notified is provisional and is subject to variation. The University reserves the right to fill-in any or all the vacancies.
9. Candidates with knowledge of Kannada speaking, reading and writing is essential in UAS, Raichur.
10. No applicant for any post shall be eligible for the appointment, if he / she is, at the time of his / her application, in permanent employment in any other Department of Government or any other State Government or Central Government or Quasi Government or any other University and has made the application without the consent of the Head of the Department or of the Government or Head of the University, as the case may be, under whom he / she is employed. Accordingly, candidates already in service (Government / Quasi Government or Private) should submit their applications through their Controlling Officer as indicated at supra. Candidates anticipating any delay in sending their applications through the proper channel may submit advance copy of the application within the prescribed last date along with the processing fee. The original application duly forwarded by the parent office must reach this Office within the date of practical / skill / written test/ interview or such candidates shall have to produce "No Objection Certificate" from their employer on the date of practical/skill/written test/interview, failing which their candidature will be rejected & will not be permitted to attend the practical / skill /written test or interview.
11. The University reserves the right of posting the selected candidates to any of the institutions under its control. The candidates are also liable to be transferred against equivalent posts in any of the Institutions of the University.
12. Applicants, if called for interview should be prepared to appear before the Selection Committee, at their own cost at the place indicated.
13. The Selection procedure will be in accordance with the Act and Statutes of the University and the qualification and Score card for Assistant Professor Entry Level cadre posts are as per the **Notification No. R/UASR/Rectt/Score-card/2021-'22 date: 18-11-2021** and published in

14. Applications must be accompanied by attested copies of Marks Sheets, Certificates, Experience Certificates, Publications, Research Notes, Certificates of Awards/ Medals, Certificates Related to Past Service etc. and the Details of Research or Related Publications, if any, in support of eligibility.
15. A relaxation of 5% shall be allowed at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer)/Differently abled / Specially abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks(For Traditional System) or 60% marks(For Trimester System) or 70% marks(For Semester System) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

A relaxation of 5% shall be provided to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.

16. Minimum marks prescribed for placing in the selection panel for Assistant Professor is 40 marks and for SC, ST, Cat-1, OBC (Non Creamy Layer) and Differently Abled / specially abled category 05 marks relaxation is prescribed
17. Candidates have to enclose their published research papers, books and publications etc., compulsorily to the applications. Those not enclosed to the applications will not be taken in to consideration.
18. Eligible candidates for Teaching Post will be called, in the proportion of 1:5 for interview.
19. The eligibility as well as the suitability of a candidate shall be considered based on the information furnished by the applicant.
20. Only the candidates belonging to SC/ST/other categories would be considered against the respective reserved posts. As such, other candidates NEED NOT APPLY against the reserved posts.
21. The roster prescribed for the posts notified herewith is in accordance with the following Karnataka State Government Orders (a) No. SiAaSul:21:SaHiMa:90, Bangalore, dt. 16.11.1995 (b) No.SiAaSul:08:SaHiMa:95, Bangalore, dt. 20.6.1995 (c) No.SiAaSul:42:SeNeNi:2001, Bangalore, dt. 23.07.2001 (d) No.SiAaSul:97:SeNeNi:2002, Bangalore, dt. 22.11.2002 (e) No.DPAR 50 SRR 2000, dt. 3.9.2005 (f) SiAaSul:107:SeNeNi:2005, dt. 5.9.2005 and as amended from time to time. Further, reservation for persons belonging to Kalyana-Karnataka Region is provided as per GOK notification dated 29.1.2014.
22. As per the stipulations in the Government Order No.SiAaSul:08:SaHiMa:95, Bangalore, dt. 20.6.1995, SiAaSul:3:SaHiMa:2015, Bangalore dtd. 3.10.2015 and subsequent amendments, in case of non-availability of eligible candidates belonging to Other Backward Classes viz., Cat.I, 2A, 2B, 3A & 3B the posts earmarked for the said categories shall be carried forward as backlog vacancies and the unfilled roster shall be carried forward in the future advertisements.
23. Further, in case of non-availability of candidates belonging to special categories under horizontal reservation such as Rural, Woman, Kannada Medium, Project Displaced Person & Ex-servicemen categories, the posts earmarked for the said categories shall be filled-up by other candidates belonging to the respective reservations as per the provisions of the Government Order No.SiAaSul:08:SaHiMa:95, Bangalore, dt. 20.6.1995.
24. The persons claiming reservation under Kalyana-Karnataka Region have to enclose requisite certificate issued by the competent Authorities in support of their claim. Persons other than those belonging to Kalyana-Karnataka Region need not apply for the posts under the said quota.
25. If suitable local candidates are not available for any post at any point of time such vacancies

will be taken as backlog and carried forward till next appointment, after which it may be treated as unreserved and filled accordingly as per section 8(5) of Karnataka Public Employment (Reservation in Appointment for Kalyana-Karnataka region), order 2013.

26. Candidates claiming reservation under Rural Category and Kannada Medium quota should possess the certificates of study in rural areas and Kannada Medium (for 10 full academic years from 1st to 10th standards or qualification prescribed for the post) issued by the competent authorities.
27. Candidates claiming reservation under Physically Challenged Quota and Ex-serviceman quota should possess the requisite certificates issued by the competent authorities.
28. The applicants those belonging to General Category & Cat.2A/2B/3A/3B, who claim reservation under Rural candidate quota, have to possess a certificate issued by the competent authority confirming that they do not come under the purview of creamy layer in the prescribed form, as per the Government Circular No.SaKal:225:BiCiA:2000, dt. 30.3.2002.
29. Ex-servicemen or children of defence personnel killed or disabled in action are exempted from payment of application fee provided they furnish appropriate certificate.
30. The candidates who have studied under Trimester System and other than 10 point grading system are required to produce the equivalent percentage certificates obtained from the respective University
31. The age of retirement in the University is 62 years for Teachers.
32. The selected candidates shall be on probation as prescribed in CAS / UAS Regulations.
33. The rate of Dearness Allowance and other allowances, if any, shall be as determined by the University / Government from time to time.
34. The qualifications for the said posts are in accordance with the Cadre and Recruitment Regulations of the University.
35. Any pressure brought on the Selection Committee or the members of the Board of Management by a candidate will disqualify the candidature for the post.
36. The selected candidates will be governed under the **NEW PENSION SCHEME** as per G.O. No. FD(SN) 04 PET 2006 dtd: 31.03.2006 and as amended from time to time.
37. For all recruitments to the posts in the University, other things being equal, the University employees shall be given preference.
38. **Selected candidates are compulsorily required to serve in the UAS, Raichur for a minimum period of 5 years and they have to execute a bond to the above said effect. Further, no applications seeking employment in other organisations shall be forwarded during the period of 5 years.**
39. **The candidates selected under reserved Quota should submit the validity of their caste and Kalyana Karnataka certificate from the Competent Authority.**
40. The selected candidates have to produce a "**Police Verification Certificate**" issued by the Competent Authority. If the Police Verification Certificate reveals that the candidate is involved in any criminal case or is involved in act which attracts moral turpitude will result in cancellation of his / her selection. However, the production of Police Verification Certificate is not mandatory for candidates who are already in regular services of Government / Statutory Bodies / Universities / ICAR Institutes.
41.
